A RESOLUTION HUMBLY REQUESTING POLICE CAPTAIN JOSEPH D. VALLE, CHIEF OF POLICE OF LUMBAN MUNICIPAL POLICE STATION, FOR THE DEPLOYMENT OF TWO (2) PNP PERSONNEL IN THE SESSION HALL OF THE SANGGUNIANG BAYAN WHO SHALL ACT AS SERGEANT AT ARMS IN ORDER TO MAINTAIN PEACE AND ORDER IN THE PREMISES AS WELL AS TO ENSURE THE SAFETY OF ALL VISITORS, EMPLOYEES AND LOCAL OFFICIALS DURING THE CONDUCT OF REGULAR/SPECIAL SESSIONS OF THE SANGGUNIAN AS WELL AS PUBLIC HEARINGS CONDUCTED BY SANGGUNIAN AND ANY OF ITS STANDING COMMITTEES

WHEREAS, the Sangguniang Bayan of Lumban in performance of its official mandates as a legislative body, conduct sessions once every week to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, the Session Hall as a sacred chamber of democracy and the humble representation of the dreams and aspirations of every Lumbeños, deemed as manor that repudiate discrimination and selectivity and therefore must be open to public at all times;

WHEREAS, the known attribute of the Sanggunian hall might be used by people with menacing plan to inflict harm to any of the members of the Sangguniang Bayan or to any person in the premises;

WHEREAS, the presence of PNP personnel will contribute greatly in the maintenance of peace and order and in assuring the safety of every person within the hall.

RESOLVED, as it is hereby, **RESOLVED** to approve the Resolution humbly requesting Police Captain Joseph D. Valle, Chief of Police of Lumban Municipal Police Station, for the deployment of two (2) PNP personnel in the session hall of the Sangguniang Bayan who shall act as the Sergeant at Arms in order to maintain peace and order in the premises as well as to ensure the safety of every visitors, employees and local officials during the conduct of regular/special session of the Sanggunian as well in public hearings conducted by Sanggunian and any of its standing committees;

RESOLVED FURTHER, to furnish the Municipal Mayor, Hon. Rolando G. Ubatay and the Chief of Police of Lumban Municipal Police Station, Police Captain Joseph D. Valle a copy of this Resolution for their knowledge and proper guidance.


