**A RESOLUTION REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THROUGH ITS SECRETARY ATTY. WENDEL E. AVISADO FOR THE RELEASE OF FUNDS IN THE AMOUNT OF TEN MILLION (PHP 10,000,000.00) PESOS TO BE UTILIZED FOR SOLAR STREET LIGHTING SYSTEM ALONG BARANGAY LEWIN-CALIRAYA ROAD, LUMBAN, LAGUNA CHARGEABLE AGAINST LOCAL GOVERNMENT SUPPORT FUND (LGSF) FOR 2021.**

**WHEREAS**, pursuant to item 3.2 of Local Budget Circular No. 117 dated February 5, 2018, the LGU can request the DBM Central Office to release and utilize the fund chargeable against the Local Government Support Fund-Assistance to Local Government Units for FY 2021;

**WHEREAS**, the Local Government Support Fund (LGSF) shall be used for financial subsidy to local government units;

**WHEREAS**, in compliance to the prescribed guidelines, the Sangguniang Bayan of Lumban, Laguna is mandated to pass a resolution requesting for the release and utilization of the funds;

**WHEREAS**, the Office of the Local Chief Executive has already identified the priority projects which shall be funded under the Local Government Support Fund (LGSF);

**THEREFORE**, on motion of Hon. Ireneo R. Baldovino duly seconded by Hon. Rhoda DM. Rabie, Hon. Rose Ann R. Añonuevo, Hon. Geronimo P. Samonte Jr. and unanimously approved by all SB Members present, it was;


**RESOLVED**, as it is hereby **RESOLVED** to approve the resolution requesting the Department of Budget and Management (DBM) through its DBM Secretary, Atty. Wendel E. Avisado for the release of funds in the amount of ten million (Php 10,000,000.00) pesos to be

utilized for Solar Street Lighting System along Barangay Lewin-Caliraya Road, Lumban, Laguna chargeable against Local Government Support Fund for 2021;

**APPROVED**, this 11<sup>th</sup> day of May, 2021.


