**A RESOLUTION HUMBLY REQUESTING HON. SENATOR MARIA LOURDES “NANCY” BINAY-ANGELES TO FINANCE THE CONSTRUCTION OF A LIGHTHOUSE AT THE DELTA OF LUMBAN RIVER.**

**WHEREAS**, it is the duty of the Sangguniang Bayan to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to their productive livelihood following said events;

**WHEREAS**, during bad weather and/or storm, zero visibility and rough waters gives difficulty to fishermen in navigating the waters of Laguna Lake resulting to collision of/to vessels, fishpens & floating debris, grounding of boats to places unknown to them and the worst, drowning;

**WHEREAS**, the fishermen needs a sturdy shelter during the above stated condition for their safety and comfort;

**WHEREAS**, there is a need for a much higher ground to station the Bantay Lawa, a local organization guarding the Laguna Lake against illegal fishing, to efficiently perform their functions and duties,

**WHEREAS**, a LIGHTHOUSE is needed to be constructed at the mouth of Lumban River to aid the fishermen in their navigation and to provide shelter during storm/bad weather and to serve as station for the Bantay Lawa,

**WHEREAS**, the Municipality of Lumban does not have the capability to finance the construction of a LIGHTHOUSE,

**NOW, THEREFORE**, and upon motion of Hon. Ireneo R. Baldovino and duly seconded by Hon. Modesto B. Abadier and unanimously approved by all Sangguniang Bayan Members present; it was;

**RESOLVED AS IT IS HEREBY RESOLVED** to request the Hon. Senator Maria Lourdes “Nancy” Binay-Angeles to finance the construction of a lighthouse at the delta of lumban river.


