RESOLUTION NO. 99 (A) S. 2022

A RESOLUTION HUMBLY REQUESTING FORMER CITY COUNCILOR CHARISSE ABALOS-VARGAS, PRESIDENT OF CIARA MARIE FOUNDATION FOR FINANCIAL ASSISTANCE AMOUNTING TO TEN MILLION PESOS (P 10,000,000.00) TO BE ALLOTTED FOR THE CONSTRUCTION OF PHASE II OF THE NEW MUNICIPAL CEMETERY OF LUMBAN

WHEREAS, Section 16 of RA 7160 otherwise known as the “Local Government Code of 1991” states “*Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.*”;

WHEREAS, Article II, Section 447 of the Act mandates the Sangguniang Bayan of Lumban to promote the general welfare of the inhabitants of the Municipality through the enactment of local ordinances and resolutions;

WHEREAS, the Municipal Government in view of the foregoing provisions, approved its plan to construct a new Municipal Cemetery for the old burial ground is already congested and the need for a decent and hygienic resting place for the departed Lumbeños must be provided;

WHEREAS, due to scarcity of resources to finance such massive project, the Municipality of Lumban being a fourth class municipality was urged to grab the opportunity to solicit assistance

from Ciara Marie Foundation and to beseech the institution's generosity and support as partner from the private sector in realizing this significant project of the Municipality;

NOW THEREFORE, on the motion of Hon. Geronimo P. Samonte Jr., duly seconded by Hon. Mark Anthony L. Lagrosa, Hon. Modesto B. Abadier, Hon. Ma. Roma R. Tablico and unanimously approved by all members present it was;

RESOLVED, as it is **HEREBY RESOLVED**, to humbly request the **FORMER CITY COUNCILOR CHARISSE ABALOS-VARGAS, PRESIDENT OF CIARA MARIE FOUNDATION FOR FINANCIAL ASSISTANCE AMOUNTING TO TEN MILLION PESOS (P 10,000,000.00) TO BE ALLOTTED FOR THE CONSTRUCTION OF PHASE II OF THE NEW MUNICIPAL CEMETERY OF LUMBAN**


